Vision

An enduring global collaboration enhancing dog health, well-being and welfare, and human-dog interactions.

- Dog issues are important around the globe, and international sharing, and cooperation is needed.

From the CEO



Dr. Brenda N. Bonnett, Chief Executive Officer

The International Partnership for Dogs (IPFD) was initiated in August 2014 by leading national kennel clubs and other stakeholders in dog health to address common goals and needs; to enhance the sharing of information and resources to support purebred dogs and all dogs; and to build a sustainable, international organization through leadership and sharing.

In 2017, our third full year of operation, our efforts focused on two major initiatives – co-hosting the 3rd International Dog Health Workshop (IDHW) with the French Kennel

Club (SCC) in Paris in April and developing the Harmonization of Genetic Testing for Dogs initiative. We also worked to solidify and expand our partnerships, to continue to address our key functions, and to expand our presence within the dog community.

The IPFD is all about participation and partnership. We are happy to report that all Partners who were due for renewal, signed on for three more years of support. We maintained and engaged new collaborating sponsors. We continue to look for more input from the dog community and have initiated proactive outreach for further kennel club, corporate, and other partners and sponsors.

The following activities/content is further highlighted on subsequent pages:

- Report on the highly successful IPFD 3rd IDHW and ongoing work arising from priorities established by the decision leaders who participated.
- Initiation of the Harmonization of Genetic Testing for Dogs initiative, building on engagement of key organizations, international experts, and an increasing number of Leadership Sponsor genetic test providers.
- Our second Summer Student project grew out of the 3rd IDHW addressing issues of antibiotic resistance. Our 2016 veterinary student from Colorado State University

actively participated in the 3rd IDHW. Both projects were generously sponsored by the Skippy Frank Fund.

- On DogWellNet.com, we expanded our Breeds Database, engaged breed clubs from numerous countries, health representatives, and experts in providing new content and expanding existing content.
- DogWellNet.com served as the hub for international efforts on various Hot Topics, including health and welfare in brachycephalic dogs, cross-breeding for health, and highlights and resources from various countries.
- Communication expanded with nine issues of the Digest (our monthly re-cap of highlights on DogWellNet.com) and increased presence on Facebook and Twitter.

In addition to the benefits of sharing information and resources, we believe there is an added strength for promoting programs locally when stakeholders/collaborators see their good work profiled internationally. We know that we all gain when we learn from others' experience, and together, we will build on collaborations in the demanding and diverse world of dogs as we advance our mission to enhance dog health, well-being, and welfare. IPFD Partners and Collaborators are truly leading by example.

From the Chair

The IPFD Board comprises high profile, internationally renowned members of the dog world, including, among the eight full- and two ex-officio members: four veterinarians; five PhDs (one double-boarded in Theriogenology and Animal Welfare); several dog breeders (including one two-time winner of Westminster; one Breeder of the Year, AKC); four current/former tenured professors; two Presidents of national kennel clubs; five judges; and eight current/former CEOs/ Executives.

The Board held three teleconferences in 2017 and two face meetings – in Paris at the 3rd IDHW and again in November in Leipzig at the World Dog Show. We continued to revise and enact our strategic planning initiatives, including striking an Election and Selection Committee and further defining Board roles and responsibilities. The Board was also active in fundraising and outreach aimed at engaging new partners.

Our major event, the 3rd IDHW, was a resounding success. Our thanks to our co-host, The Société Centrale Canine (the French Kennel Club), for a perfectly organized event in a stunning locale. The intense work done beforehand by our CEO, other IPFD consultants, and our collaborators resulted in a provocative and relevant program, attendance by an impressive group of decision leaders from many stakeholders in the dog world, and a stellar group of speakers. The issues addressed in the themes are those challenging the global dog community.

The results of this workshop continue to support and inform a wide array of activities in many countries; specific actions arising will help us move ahead to advance dog health and welfare, globally. The IDHWs continue to support and influence various stakeholder groups, including, veterinary initiatives and international conferences. Although topics

like health and welfare in brachycephalic dogs are controversial and challenging, we must meet these challenges head on and collectively.

The Harmonization of Genetic Testing for Dogs initiative has a great potential to support breeders, veterinarians, kennel clubs, breeding advisors, and more, and it was exciting to see this progress to a reality in 2017. We anticipate a successful launch in early 2018.

The IPFD remains committed to bringing together decision-leaders in the dog world to facilitate the international actions needed to support dogs and human-dog interactions, globally.

A strong, committed effort by a wide array of stakeholders in the dog world is needed to advance common goals for the well-being of our canine companions.

Among the highlights from 2017:

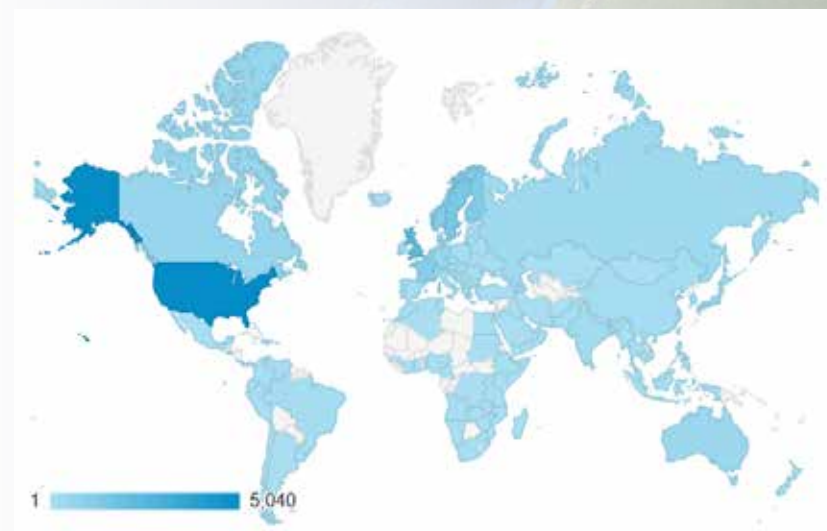
- Following the 3rd IDHW, we set up Forums for working groups from the IDHWs, as well as for international breed discussions.
- A Beta Test version of the Harmonization of Genetic Testing for Dogs database for collaborators and Leadership Sponsors went online in December, with a public launch planned for the first quarter of 2018.

- Over 150 breeds are now in our Breeds Database; 18 new breed clubs are providing data; more international data is being added in several languages.
- Our global reach increased, with website users in 144 countries, up from 128 countries in 2016.

International Dog Health Workshops: Overview

Breed-related health problems in dogs have received increased focus over the last decade. Responsibility for causing and/or solving these problems has been variously directed towards dog breeders and kennel clubs, the veterinary profession, welfare scientists, owners, regulators, insurance companies, and the media. In reality, all these stakeholders are likely to share some responsibility, and optimal progress on resolving these challenges requires all key stakeholders to work together.

IPFD, together with an alternating host organization, holds biennial meetings: the International Dog Health Workshops (IDHWs).

These meetings bring together a wide range of stakeholders in dog health, science, and welfare to improve international sharing of information and resources, to provide a forum for ongoing collaboration, and to identify specific needs and actions to improve health, well-being and welfare in dogs.

3rd IDHW: April 2017 - Paris

IPFD Partner, The Société Centrale Canine (French Kennel Club), hosted the 3rd IDHW in Paris.



The workshop included 140 decision leaders from 23 countries and was structured around six important issues facing those who work to improve dog health:

- **Breed-Specific Health Strategies:** Needs and opportunities; innovations, nationally and internationally.
- **Exaggerations and Extremes In Dog Conformation:** Health, welfare, and breeding considerations; national/ international efforts.
- **Education and Communication:** How can international collaboration improve education and communication within and across stakeholder groups (esp. between veterinarians and breeders, using the example of antimicrobial resistance)?

- **Behaviour and Welfare:** How can we better integrate actions to address issues in welfare, behaviour, and health in breeding and raising dogs?

- **IPFD Harmonization of Genetic Testing for Dogs:** An international, multi-stakeholder initiative to address selection, evaluation, and application of genetic testing.

- **Show Me The Numbers:** Integrating information from various sources for prevalence, risks and other population-level information; latest national and international strategies to collect data and disseminate information.

Moving from Information and Collaboration to Action

A number of exciting actions were agreed to during the IDHW. These included setting up working groups to create tools to help breed clubs accelerate the implementation of breed-health strategies, review aspects of extreme conformation, and share useful information on behavior.

The meeting also heralded the development of an online resource of relevant information describing quality measures for canine DNA testing.

A demand for more and better data and evidence was a recurring message stressed across all themes.

The IDHW confirmed the benefits from inclusion of a diverse range of stakeholders who all play relevant and collaborative parts to improve future canine health. Firm actions were set for progress towards improving breed-related welfare.

In the summer of 2016, we welcomed our first IPFD Student, Kelly Arthur – now a 4th year veterinary student from Colorado State University. The 3rd IDHW in Paris was the culmination of [Kelly's project](#), where her poster (above) was displayed alongside an array of canine research projects from around the world. Kelly actively participated in the Welfare and Behaviour theme.

The success of her project was instrumental in securing support for our 2017 IPFD Student Project, which was also generously funded by the **Skippy Frank Fund**.

Kelly continues to contribute to IPFD and DogWellNet.com, fostering IPFD's values of communication and collaboration leading to

actions that improve dog health and welfare, including spearheading efforts that resulted in a new, required course in animal welfare at CSU.

Growing out of priorities identified at the 3rd IDHW, Ariel developed articles about Antimicrobial Resistance (AMR) and published The B.A.R.K. Blog | Bacterial Antimicrobial Resistance Knowledge on DogWellNet.com.

Ariel's posts also included vlogs (video blogs), which featured filmed interviews with experts in AMR and video shares from various stakeholders addressing interesting and controversial aspects of the AMR issue. The objectives of [Ariel's project](#) included:

- To research the epidemiology of antimicrobial resistance in dogs on an international level.
- To use a 'One Health' approach as a means of integrating knowledge for gathering information from experts in the veterinary, human medical, and environmental fields related to antimicrobial resistance (AMR) and behavior change.
- To integrate alternative media methods of on-line learning as an educational experience for veterinarians, breeders, dog owners, and others involved with canine care.
- To persuade stakeholders to change behaviors to a more prudent use of antimicrobials (PUA).

The Harmonization of Genetic Testing for Dogs: Background

From our beginnings, addressing the challenges of canine DNA testing has been one of IPFD's key objectives.

We have long recognized the input and work of many other experts and organizations in this area; however, the total lack of oversight or standards for DNA testing results in many challenges for dog breeders, veterinarians, and breeding advisors. An initiative was envisioned to foster international collaboration to develop the resources needed to help realize the full potential of genetic testing to advance health and welfare of dogs and to support their caring owners and breeders.

After years of building international, multi-stakeholder collaboration, these efforts came to fruition in 2016 with the launch of the [Harmonization of Genetic Testing for Dogs](#) (HGTD) initiative. Once fully implemented, this open access, sustainable online resource will:

- Catalog information provided voluntarily from genetic test providers (GTPs) on expertise, quality assurance, activities, and resources; tests, validity, and application.
- Coordinate a program for standardized proficiency testing and potentially peer review and audit.
- Collate/assemble existing and new resources for genetic counselling and education; and provide the foundation for further developments.

2017 Milestones

2017 was a pivotal year for the HGTD initiative, with the achievement of several key milestones – including the allocation of additional financial and staff resources, database development and the enrollment of an initial group of 17 Leadership Sponsor Genetic Test Providers.

Summary of 2017 HGTD Milestones:

- Funding for 2017 allowed us to hire a Project Manager (Aimee Llewellyn-Zaidi).
- 17 Leadership Sponsor Genetic Test Providers (GTPs; 'labs') have been enrolled and have provided financial and expert support to the project.
- The prototype for the Quality Database was successfully demonstrated and profiled at the 3rd IDHW and the Canine and Feline Genetics and Genomics meeting in Minnesota.

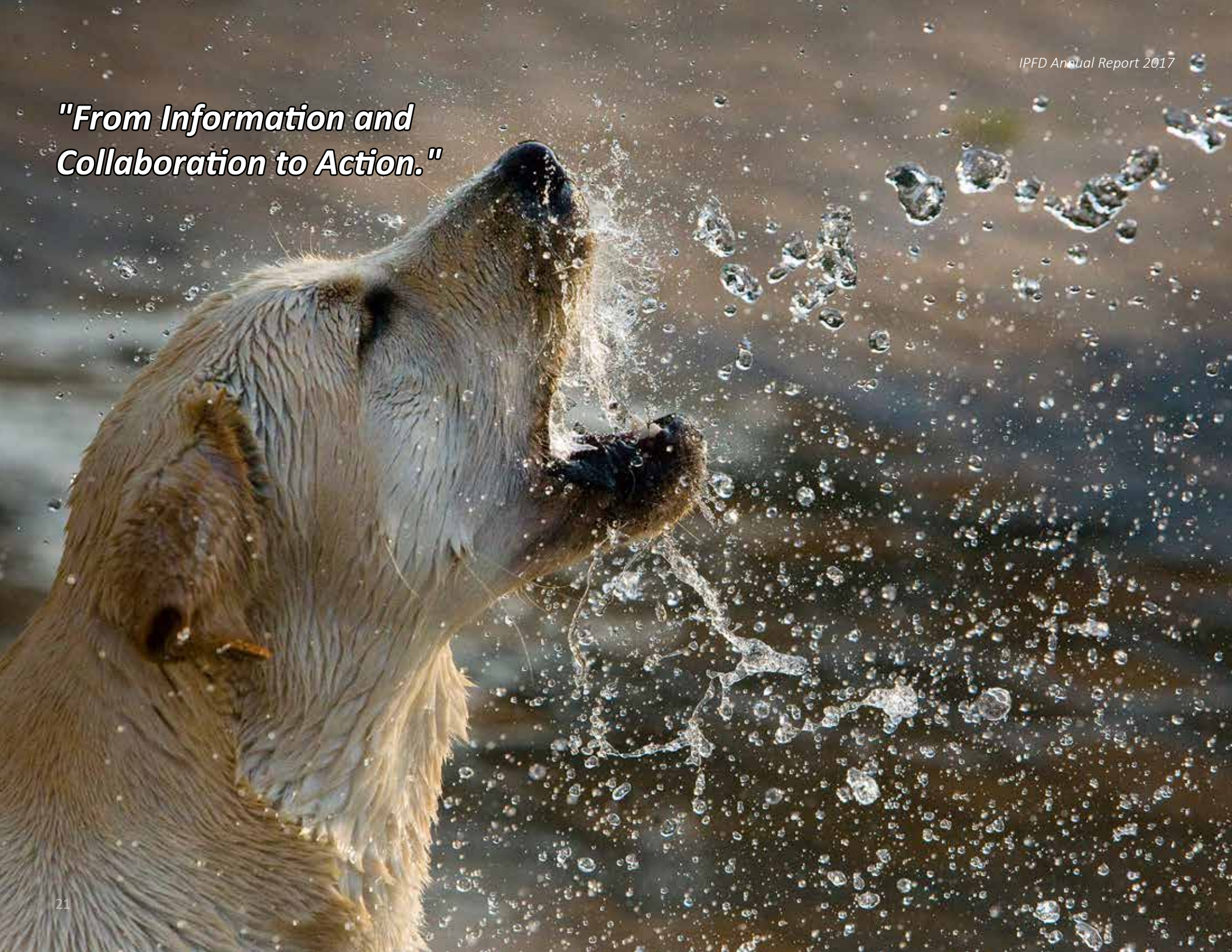
- Development has continued and a beta-test version has been online for collaborators and Leadership Sponsors since December 2017; public launch planned for the first quarter of 2018.

Looking ahead...

2017 was a challenging and exciting year. The organization and its activities continue to expand in terms of content and influence.

The Harmonization of Genetic Testing for Dogs (HGTD) made great strides in 2017 and will be public early in 2018. The collection and management of data from respected Genetic Test Providers (GTPs) has proved challenging, although this is not entirely unexpected given the unregulated nature of this field and lack of standardization, on many levels. All this, however, underlines the need for the initiative. 2018 will present both opportunities and challenges.

Content on DogWellNet.com continues to expand. Many individual breeders, breed clubs, and health representatives contact

with an interest in sharing material, and we offer them as much guidance and technical support as they need to get their resources onto our website. These opportunities are limited only by the amount of time and effort volunteers are willing and able to contribute.

We have instituted a revamped Partner engagement strategy, and our major partners have identified "Liaisons" to link with us, to share their important work with IPFD, and to take full advantage of their partnership. They are very excited about the potential for the HGTD to support their members.

We have been quite successful in gaining Sponsorship for the HGTD, and we continue efforts to engage new Partners for the initiative and the IPFD. In 2018, we will bolster our fundraising strategies to move forward in strengthening our organization and making this important work for dog health and welfare truly sustainable.

We stepped up our social media presence through our Facebook page, and, toward the end of the year, we implemented new promotion strategies to expand our reach. Those accessing our page find it relevant and useful, and we anticipate increased growth across all social media platforms in 2018.

The 3rd International Dog Health Workshop (IDHW) was a tremendous success. Great

thanks are due to our co-host, the French Kennel Club; all the participants; and our sponsors, Agria Pet Insurance and Royal Canin. However, organizing the program is a highly time-, energy-, and resource-intensive process for IPFD. This event is a working meeting, not a typical conference. Its success hinges on engaging theme leaders to define and prioritize topics that will inspire attendees and to assemble resource materials. A lot of time and effort also goes into promoting IDHWs to decision leaders.

Clearly this work paid off. The attendees, most of whom are engaged in demanding and influential positions in the dog world, embraced the overall workshop and their topics, identified key actions, and committed to making things happen. Similar work must go on during 2018/2019 to ensure an equally successful 4th IDHW in the UK in June 2019 with our hosts from The Kennel Club.

IPFD's model and resources (a modest budget and small group of consultants and Board Members) are intended to facilitate the activities of our stakeholders to achieve their priorities for the health and welfare of dogs. We must continue to refine this model to sustainably support these important collaborative international efforts.
